**VERIFICATION OF BUNKERING**  
**(Pollution Tax Exemption for Vessels Operating Outside Florida Waters)**

This is to certify that petroleum products, as defined in Florida Statutes 206.9925(4), purchased on or after \_\_\_\_\_ from SSI Petroleum (aka SSI Lubricants, LLC) were purchased exempt from the Water Quality and Inland Protection Taxes as described in F.S. 206.9935 (2)&(3).

The exemption is based on F.S. 206.9941 (7), "Petroleum products bunkered into marine vessels engaged in interstate or foreign commerce by the licensed refiner, importer, jobber, wholesaler, producer, or dealer who first imported said products are exempt from the taxes imposed under s206.9935(2) and (3)."

This verification request will be valid for a period of two (2) years from the date above.

Note: there are no exemptions concerning the Coastal Protection Tax. This tax will be assessed on all qualifying sales at the rate established under F.S. 206.9935(1).

Purchaser is aware that if this exemption is falsely claimed or if they fail to qualify at the time of purchase, then the purchaser will be liable for all taxes imposed under P.S. 206.9935. Purchaser will also be liable for penalties and interest for false exemption claims.
